

Midlands Funds Management Limited presents this Annual Report to the investors of Midlands Smarter PIE Fund for the year ended 31 March 2024 ("accounting period").

Details of the Scheme

The name of the scheme is Midlands Smarter PIE Fund (formally Midlands Income Fund ("Scheme")). It is a managed investment scheme under the Financial Markets Conduct Act 2013 ("FMC Act") and a PIE (Portfolio Investment Entity) as defined in section YA 1 of the Tax Act. The Manager of the Scheme is Midlands Funds Management Limited ("Manager"). The supervisor of the Scheme is Trustees Executors Limited ("Supervisor").

A Replacement Product Disclosure Statement for the Scheme was registered on 2 April 2024, and the Scheme's status is open for applications.

The latest Fund Update for the Scheme is dated 30 June 2024 lodged with the Registrar on 29 July 2024.
